Sir,

This has reference to Appeal dated 05-07-2018 filed by you against the decision of NBA for not granting accreditation to Diploma Electrical and Electronics Engineering program of your Institute, communicated vide NBA's letter of even number dated 09-06-2018.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 02-08-2018. On the recommendation of the Appellate Committee, an Expert Committee conducted on-site evaluation of the program during  $22^{nd} - 23^{rd}$  September, 2018. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. On their recommendation and the recommendation made by the Appellate Committee in its meeting held on 14-11-2018, the competent Authority in NBA has approved the following accreditation status to the program as given in the table below:

- 4. The program has been granted accreditation for three years. Centre for Computers and Communication Technology Burbotey, Chisopani, PO Nandugaon, South District, Sikkim- 737 123 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible to be considered by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a revisit, as deemed appropriate by NBA Committees.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Centre for Computers and Communication Technology Burbotey, Chisopani, PO Nandugaon, South District, Sikkim-737 123. as a whole. As such the Institution should nowhere along with its name including on its letter head etc., write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program (s) and level of the program (s) accredited and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
- 6. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of your Institute.
- 7. The accreditation status awarded to the program as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
